1 Course Details

1.1 Calendar Description

Students will explore and consider the found object and appropriation in art, the use of language and text in art, and other conceptual art practices in various media. In a context of critical reading, writing, class exercises and discussion - students will continue developing their technical skills in video and sound production. We may also consider such forms as collage, the artist book and/or artist multiple, performance, social practice art, and other experimental studio strategies.

Pre-Requisites: SART*2800

Restrictions: Registration is limited to students registered in the Art History; Sexualities, Genders, and Social Change; or Studio Art specializations with an average of 70% in all ARTH and SART course attempts. Students are initially restricted to two SART courses per semester. For registration in additional SART classes, contact the SART Faculty Advisor.

1.2 Course Description

This course is designed to establish a focused approach in preparation for independent studio research and production. The semester will include technical exercises, readings, field trips, three medium-specific assignments, and a group symposium based on the students' own research in close consultation with the instructor. Works produced in class will be documented and archived by students on the course blog throughout the term with images and textual descriptions.

Readings and illustrated lectures will provide a historical and current base for assignments while initiating class discussion. This structure aims to maintain a balance between form and concept, and provide participants with the tools and critical awareness for a rigorous exploration of their own work.

Our class dynamic is of primary importance, and participation in the studio community is essential to develop a critical and supportive atmosphere. This practice should extend to the larger art community, as students begin to participate within a broader context.

Critiques take the place of final exams. They will be scheduled at regular intervals during class time.

- Reflect on ideas about a broad range of subjects as they are explored by contemporary artists
- 8. Manage time effectively and meet deadlines in class

Assignments will be graded on conceptual rigour, ambition, originality, and technical execution. This means a successful demonstration of intent, appropriate use and control of materials in terms of intent, and consideration of presentation and format. Assignments are to be completed on time on the course blog. A late deduction of 5% per day applies to late assignments. Assignments more than 10 days late will not be accepted.

Critiques are mandatory. They take the place of exams and are factored into assignment evaluations.

7.1 FACILITIES

Students are expected to supply some basic tools and supplies to complete the course:

- Mobile phone with camera/video capabilities or digital camera
- Computer with access to free online software for editing video/audio
- External hard drive / solid state drive / USB for data storage
- Regular household materials (will be discussed in class)

8.5 Accessibility
